

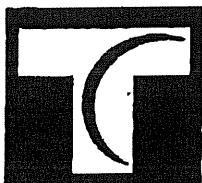

**Quarterly Certificate of
Compliance with Commercial Limits in Children's Programming
April, May, June 2001**

KTEL-TV has a strict policy for compliance that includes the following procedures:

- Children's programming is identified by the Telemundo Network by programming memos distributed to all local affiliates.
- When a local commercial order is placed, the AE, Traffic and Master Control Operator determine if any product affiliation occurs.
- Traffic prepares program log information from formats provided by the Network and if necessary, limits the time in local breaks to insure compliance.
- When a local spot is dubbed, tape operators examine the spot for content and note any character or program mentions, or anything they find questionable. If product affiliation occurs, Traffic Manager and AE are alerted that the commercial cannot air in particular show.
- If any program related copy is found, the Station Manager, and the Account Executive are alerted.
- All spots are dubbed and checked by log deadlines. There is a 48-hour lag time between the time a spot arrives and the time it can be logged.
- The Traffic Department re-programs available time during Children's programming to accept only promotional or public service announcements.
- The Traffic Department and Master Control reassess all commercial matter after the log is printed.
- If technical difficulties or transmitter failure occurs during Children's programming, commercials are not rescheduled by Master Control.
- KTEL administration checks the Network log and notes the total amount of commercial time scheduled.
- All appropriate personnel are provided with a written policy of procedure for Children's Compliance

This certifies that during the past calendar quarter the above-referenced station and its network as a standard practice, formatted and broadcast the children's programs to assure that they would be within the statutory limits permitted for commercials in such programs. There were no program-length commercials in the Second Quarter of 2001. A report listing actual time aired in Children's Programming is attached.

The Children's Compliance report is compiled from program logs by Abby Bowen, KTEL-TV Administrator.

On Behalf of KTEL-TV, I certify that the Children's programming aired by KTEL-TV during the period April 11, 2001 through June 30, 2001 contained no more than the maximum amount of commercial time permitted under the Communications Act. Specifically, I certify that:

- 1) Each hour of Monday through Friday Children's programming (containing either one hour-long program or two consecutive half-hour programs) contained no more than twelve (12:00) minutes of commercials and a half-hour Children's program which was not part of an hour's block of Children's programming contained no more than six (6:00) minutes of commercials.
- 2) Each hour of weekend Children's programming (containing either one hour-long program or two consecutive half-hour programs) contained no more than ten and a half (10:30) minutes of commercials and a half-hour Children's program which was not part of an hour's block of Children's programming contained no more than five and a quarter (5:15) minutes of commercials, except as detailed on attachment.
